Sub: Construction of IHHL for Left out of Baseline (LOB) families – Reg.

Sir/Madam,

With reference to above, I would like to inform you that based on the entry of LOB family details, Ministry of Drinking Water and Sanitation (MDWS) has considered the state proposal for approval in the 52nd National Scheme Sanctioning Committee (NSSC) meeting held on 1st March, 2019.

The following points may please be noted while constructing the toilets for Left Out of Baseline families –

1. The sanitation status of all households entered in IMIS (J02 module) is being verified by 3rd Parties.
2. State approval is being given against the entries made by the districts subject to the condition that in case any households found to be ineligible for receiving incentive, during 3rd Party verification, construction of toilets for such families shall be treated as irregular/without approval by the districts.
3. District shall have to take full responsibility, not to give incentives under LOB category for any families who are not eligible for incentive as per SBM-G guideline.
4. Construction of all household toilets for **eligible families** shall have to be completed within **31st March, 2019**. No extension of date of construction shall be considered under any circumstances.
5. Geo-tagging, Physical & Financial progress shall have to be completed in **J04 module** of SBM-G IMIS.
