BACKGROUND:

To accelerate the efforts to achieve universal sanitation coverage and to put focus on safe sanitation, the Prime Minister of India launched the Swachh Bharat Mission (SBM), on 2nd October, 2014 with a vision to achieve open defecation free states by 2nd Oct 2019 as a befitting tribute to 150th birth anniversary of Mahatma Gandhi. Assam, is an open defecation free (ODF) State as declared on March 2019 based on the BLS 2012. ODF status/achievements are sustainable, provided that there is a post-ODF intervention with clear implementation arrangements that offer continuous engagement and intervention with ODF communities, incentive provisions and motivation through development interventions, and recognizes and appreciates the resourcefulness of people to attain and retain their ODF status. SBM G envisions on ODF Plus with focus on solid & liquid waste management (SLWM).

OBJECTIVE:

Since the objective of SBM (G) is to bring about improvement in cleanliness, hygiene and general quality of life in rural areas, ODF Plus is one of the key components of the programme. In view of the Covid 19 pandemic, focus is to be given on sensitization on Covid 19 along with WASH. The WASH Monitoring Specialist would ensure that State Annual Implementation Plan (AIP) have an Open defectation Free (ODF) Plus component detailing activities, outputs and resources needed for sustaining the SBM outcomes as well as continued investment on awareness, behaviour change, capacity building and community mobilization for collective action to maintain the ODF status.
