**The key task and responsibilities of the Project Steering Committee will be as follows:-**


1. Provide project oversight, direction and guidance as needed.

9. Promote a participative strategy in the implementation such that the responsibility and ownership is shared across the organization.
10. Regular review of Project deliverables and enforcement of smooth and time bound implementation.

**Role of NIC representatives will be as follows:-**

1. NIC Official will extend technical guidance to the department as and when required.
2. NIC Official will also be the coordinating point between the department and the WDC.
3. NIC representatives will need to be a part of the deptt. technical committee for any website related areas.

**Roles and Responsibilities of the Content Managers / Master Trainers / Site Administrator:-**

Content Managers:-

- To identify the content in their respective unit.
- Classify the content into categories.
- Submit to webmaster for review.
- Convert the content into format that is ready for uploading onto the website.

Master Trainer:-

- They would undergo e-Prastuti Master Trainers Certification Programme.
- They would initially be trained by the Website Development Cell (WDC) for website management and they in turn would provide trainings to other departmental personnel.
- They would be imparted with trainings on any new developments by WDC. Thus Master Trainers are required to provide the sustainability for the Website Content Management.

Site Administrator :-


- An official having IT skill set.
- Would be overall responsible for administration & management of the website.
- Will assign Role & Privileges to the department content managers.
- Manage the top level directory structure (sector-wise) in the Website.
- Ensure the updating of data in the Website Directory.

**Note :-** Web Information Manager of the Department Project Steering Committee will oversee the working of the Content Managers, Master Trainers and Site Administrator.
